ORDER

As per paper read (1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2017-18 from colleges for courses affiliated to this University. The Principal, Believers Church Medical College Hospital Kuttampuzha Thiruvalla-MM031 has submitted application for the continuation of provisional affiliation for the year 2017-18 vide paper read (2) above.

On verification of the applications it is found that the college has submitted necessary documents and remitted fee for the continuation of provisional affiliation. As per read (3) above, the inspection commission has submitted the inspection report after conducting the inspection at the college and pointed out that the mobile jammer are not installed at examination hall and confidential room. The Scrutiny Committee vide paper read (4) above, has directed the college to rectify the deficiencies pointed out by the inspection commission and submit the compliance report. As per paper read (5) above, the college has submitted the compliance report after the rectification of deficiencies. The Scrutiny Committee held on 20-05-2017 verified the compliance report and recommended to grant continuation of provisional affiliation to the college for the year 2017-18. As per paper read (7) above the Ministry of Health and Family Welfare, Govt. of India has granted renewal permission to the college for conducting the MBBS course for the year 2017-18

Sanction, has therefore been accorded by the Vice-Chancellor by implementing the above decision of the Governing Council to grant continuation of provisional affiliation to Believers Church Medical College Hospital Kuttampuzha Thiruvalla-MM031 for conducting the following courses with an annual intake of students mentioned against each during the academic year 2017-18 subject to the conditions detailed below:-

- 1 Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 The College should remit annual administration fee fixed for UG course for the academic year 2017-18
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
