Sir/Madam,

I am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 4<sup>th</sup> batch of 150 (one hundred fifty only) MBBS students at Believers Church Medical College Hospital, Kuttapuzha, Kerala u/s 10A of the IMC Act, 1956 for the academic Year 2019-2020.

2. The Board of Governors has granted approval after considering the Compliance Verification Assessment Report (11<sup>th</sup> April, 2019 ) and documentary evidence submitted by the college authorities explaining the mismatch between the bed occupancy and clinical investigations before the Hearing Committee on 07.05.2019 and the recommendations of the Hearing Committee.
3. The Permission is valid for one year and for admitting only one batch of 150 students during the academic year 2019-2020. The next batch of students in MBBS course will be admitted in the college only after permission of Board of Governors in supersession of the MCI for renewal/recognition.
4. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.
5. Discrepancies, if any, may be immediately brought to the notice of the Board of Governors in supersession of the MCI and the State Govt.
