ORDER

As per paper read (1) above, University invited applications for continuation of provisional affiliation for the Academic year 2019-20 from colleges for courses affiliated to the University. The Principal, Believers Church Medical College Hospital Kuttampuzha Thiruvalla-MM031 vide paper read (2) above has submitted application for the continuation of provisional affiliation for the year 2019-20 .

2) On verification of the applications it is found that the college has submitted necessary documents and remitted fee for Continuation of Provisional Affiliation . Inspection commission deputed for assessing the facilities in the college vide paper read(3) above submitted inspection report after conducting the inspection. After scrutinizing the inspection report, the Scrutiny Committee vide paper read(4) above pointed out that "there is deficiency of an Associate Professor in Psychiatry and deficiency of mobile jammer in the examination hall". The deficiencies were intimated to the college and vide paper read(5) above, the college has submitted the compliance report after rectifying the deficiencies. The Scrutiny Committee, verified the compliance report and vide paper read (6) above recommended to grant Continuation of Provisional Affiliation to the college for the year 2019-20. The Governing Council, vide paper read (7) above, decided to grant Continuation of provisional affiliation to Believers Church Medical College, Thiruvalla on production of LoP/Renewal recognition from MCI/GOI for the academic year 2019-20. The Medical Council of India, vide paper read (8) above, has granted renewal of permission for MBBS course for 4th batch(100 seats) to Believers Church Medical College Hospital, Thiruvalla for the Academic year 2019-20. The college has submitted order reconstituting the college Council for the year 2019-20.

3) Sanction, has therefore been accorded by the Hon'ble Vice-Chancellor by implementing the Governing Council decision to grant continuation of provisional affiliation to Believers Church Medical



College Hospital Kuttampuzha Thiruvalla-MM031 for conducting the following course with an annual intake of students mentioned against it during the academic year 2019-20 subject to the conditions detailed below:-

- 1 Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2019-20. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 The College should remit annual administration fee fixed for UG course for the academic year 2019-20
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
