### ORDER

1. The Principal, Believers Church Medical College Hospital , Thiruvalla vide paper read (1) above, had submitted application for provisional affiliation for starting of **MD Anaesthesiology** with an intake of **2 seats** for the academic year **2021-22**.
2. University conducted inspection at the college and the inspection commission submitted inspection report vide read (2) above which was scrutinized by the scrutiny committee. The scrutiny committee vide read (3) above, recommended to grant Consent of Affiliation. Based on the recommendation of the Scrutiny Committee University had issued Consent of Affiliation vide read (4) above to Believers Church Medical College Hospital, Thiruvalla for starting of MD Anaesthesiology with an intake of 2 seats the academic year 2021-22.
3. The college has received Letter of Permission from National Medical Commission vide read (5) above and subsequently, the Principal, Believers Church Medical College Hospital, Thiruvalla has submitted application for Starting of MD Anaesthesiology with an intake of 2 seats for the academic year 2021-22. The college has remitted requisite amount of Affiliation fee and Refundable deposit for Starting of MD Anaesthesiology with an intake of 2 seats for the academic year 2021-22.
4. University conducted final inspection at Believers Church Medical College Hospital, Thiruvalla and the inspection commission submitted the inspection report vide read (6) above which was scrutinized by the scrutiny committee. The Scrutiny Committee vide read(7) above has recommended for granting Provisional Affiliation for Starting of MD Anaesthesiology with an intake of 2 seats for the academic year 2021-22.
5. The matter of granting Provisional Affiliation for Starting of MD Anaesthesiology with 2 seats for the academic year 2021-22 was placed before the Sub Committee of the Governing Council and the Sub Committee vide read (8) above has recommended for granting Provisional Affiliation for Starting of MD Anaesthesiology with 2 seats at Believers Church Medical College Hospital, Thiruvalla for the academic year 2021-22.



6. Governing Council vide decision read (9) above, has approved the minutes of the Sub Committee and decided to grant provisional affiliation for Starting of **MD Anaesthesiology** with **2 seats** at **Believers Church Medical College Hospital, Thiruvalla** for the academic year **2021-22**.

7. Sanction is therefore, accorded to grant **Provisional Affiliation** to **Believers Church Medical College, Thiruvalla** for Starting of **MD Anaesthesiology** with **2 seats** for the academic year **2021-22** subject to the conditions detailed below.

1. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
3. Affiliation granted is strictly provisional and only for the academic year 2021-22. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
4. Admission to the next academic year shall be done only after obtaining prior permission from the University.
5. The College should remit **Annual Administration fee of Rs.220500/-** (Two lakh twenty thousand five hundred only) per course after closure of admission for the academic year 2021-22.
6. The College should collect fees (one time payment at the time of admission) from the students to be remitted to the University as follows: -
