**ORDER**

The University invited applications for Continuation of Provisional Affiliation for the academic year 2023-24 from colleges for courses affiliated to this University, vide paper read (1) above. The Principal, Believer's Church Medical College Hospital, Thiruvalla has submitted applications for Continuation of Provisional Affiliation for the academic year 2023-24 vide paper read (2) above.

On verification of the applications, it is found that the college has submitted necessary documents and remitted fee for Continuation of Provisional Affiliation for the academic year 2023-24.

University posted inspection at Believer's Church Medical College Hospital, Thiruvalla in connection with Continuation of Provisional Affiliation for the academic year 2023-24 and the inspection team submitted the inspection report after conducting the inspection, vide paper read (3) above. Scrutiny Committee scrutinized the inspection report and recommended to grant Continuation of Provisional Affiliation to Believer's Church Medical College Hospital, Thiruvalla for the academic year 2023-24, vide paper read (4) above.

Considering the recommendation of the Scrutiny Committee, Hon'ble Vice Chancellor accorded permission to grant Continuation of Provisional Affiliation to Believer's Church Medical College Hospital, Thiruvalla for the academic year 2023-24, subject to ratification of the Governing Council and to intimate the name of the College to DME/CEE, as the allotment process was already on. Accordingly, University forwarded name of the college to CEE/DME.

75<sup>th</sup> Governing Council, vide decision No. 75.05 ratified the action of the Hon'ble Vice Chancellor in having granted Continuation of Provisional Affiliation to Believer's Church Medical College Hospital, Thiruvalla for the academic year 2023-24 and forwarding the same to DME/CEE, vide paper read (5) above.

Accordingly, orders are issued granting Continuation of Provisional Affiliation to Believer's Church Medical College Hospital, Thiruvalla for conducting the following courses with an annual intake of students mentioned against each during the academic year 2023-24 subject to the conditions detailed below:-

- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2023-24. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- The College should remit annual administration fee fixed for UG/PG course for the academic year 2023-24. The College shall produce the orders regarding the constitution of College Council for the academic year 2023-24 during the time of student data verification.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
